Rules & Regulations

2024 Parade Theme: “A Forest Fairytale”

1. Group or individuals may participate in the parade.
2. Costumes will not be judged.
3. It is suggested that costumes reflect the theme of the parade “A Forest Fairytale.”
4. Businesses or organizations may enter their mascots in the parade.
5. Twirlettes will be exhibition only. Groups must maintain a standard walk to maintain the parade pace.
6. Units must maintain a distance of 40 to 60 feet between parade units. Please adhere to these lengths to avoid gaps in the parade.
7. No motorized vehicles will be allowed in the parade, including pick-up trucks, flatbed trucks, cars, four wheelers, mules, etc. The only exception will be one vehicle permitted for each twirlette or dance group for the purpose of music.
8. **Pre-registration is required** for all organizations with a vehicle. The driver of the vehicle will be required to submit a valid driver’s license and proof of insurance. Without the information, you will not be permitted to participate. This information should be forwarded with application by September 20, 2024. All drivers **must be at least 18 years old**. Driver’s license and proof of insurance can be emailed to contact@forestfestival.com
9. **No political, controversial, or business advertisement may be represented in the Parade of Children. No individual running for any political office/position may walk/ride or be represented in any way in a special unit or other parade entry. If the person is currently elected or appointed, they may participate as the current title.**
10. All entrants must obey the instruction of the parade officials to prevent delays in the parade. These officials will be properly identified and have authority to disqualify or eject entrants from the parade.
11. Candy cannot be thrown along the parade route; however, it can be handed out.
12. Failure to comply with the rules and regulations may result in disqualification or ejection from the parade and removal from future participation.
13. The Mountain State Forest Festival reserves the right to screen and reject or approve all entries. The entertainment and enjoyment of the parade viewers is of the utmost importance.
